Mr. McGee made a motion to adopt the following resolution:

**WHEREAS**, Barbara Wiedenbein resigned as Union Township Trustee on  
January 1, 2009 ; and

**WHEREAS**, Barbara Wiedenbein’s term as Township Trustee expires on  
December 31, 2009 ; and

**WHEREAS**, in accordance with Ohio Revised Code Section 503.24 the Board of  
Township Trustees shall appoint a person having the qualifications of an elector to fill the  
vacant Trustee position for the unexpired term or until a successor is elected; and

**WHEREAS**, fewer than thirty (30) days have passed since the resignation of Barbara  
Wiedenbein as Trustee; and

**WHEREAS**, the Board of Township Trustees desires to fill the unexpired term of  
Barbara Wiedenbein by appointing Timothy M. Donnellon a qualified elector in Union  
Township, as Township Trustee;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Union  
Township, Clermont County, Ohio, as follows:

**Section 1:** That Timothy M. Donnellon is hereby appointed  
Township Trustee to fill the unexpired term of Barbara Wiedenbein in  
accordance with R.C. 503.24 and to serve as Township Trustee until  
December 31, 2009.

**Section 2:** That this Board upon majority vote does hereby dispense with the  
requirement that this resolution be read on two separate days, pursuant to Section  
504.10 of the Ohio Revised Code and hereby authorizes the adoption  
of this resolution upon its first reading.
