RESOLUTION 2009-12

The Board of Trustees of Union Township, Clermont County, Ohio met in regular session at the Union Township Civic Center on July 28, 2009 with the following members present: Robert McGee, Matthew Beamer, and Timothy Donnellon

MR. DONNELLON \_\_\_\_\_ made a motion to adopt the following Resolution:

RESOLUTION AMENDING UNION TOWNSHIP PLANNING & ZONING DEPARTMENT FEE SCHEDULE AND ESTABLISHING UNION TOWNSHIP FIRE DEPARTMENT FEE SCHEDULE

WHEREAS, the Board of Township Trustees of Union Township, Clermont County, Ohio has established and adopted Zoning Regulations governing the unincorporated lands of Union Township pursuant to Chapter 519 of the Ohio Revised Code; and

WHEREAS, the Board of Township Trustees of Union Township, Clermont County, Ohio has previously adopted fees, administered by the Union Township Planning & Zoning Department, governing the issuance of permits and applications required in conjunction with the administration and enforcement of the *Union Township Zoning Resolution* thereto for all unincorporated lands under the jurisdiction of the same; and

WHEREAS, the Board of Trustees of Union Township, Clermont County, Ohio now wishes to amend the existing fee schedule administered by the Union Township Planning & Zoning Department, last revised April, 2000, to those fees identified within the Fee Schedule included as EXHIBIT A to this resolution; and

WHEREAS, the Board of Trustees of Union Township, Clermont County, Ohio also wishes to establish a new fee schedule governing the review and issuance of permits by the Union Township Fire Department assuring compliance with all relevant Fire Safety and Prevention provisions outlined within the *Ohio Fire Code*, the *Ohio Building Code*, or as otherwise required by law or national standards, to those fees identified within the Fee Schedule included as EXHIBIT B to this resolution;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Union Township, Clermont County, Ohio, as follows:

SECTION 1: The Board of Trustees of Union Township, Clermont County, Ohio hereby amends the Union Township Planning & Zoning Department Fee Schedule, thereby adopting the fee schedule identified as EXHIBIT A, with an effective date of September 1, 2009.

SECTION 2: The Board of Trustees of Union Township, Clermont County, Ohio hereby adopts the Union Township Fire Department Fee Schedule, identified as EXHIBIT B, with an effective date of September1, 2009.

SECTION 3: The fee schedules identified as EXHIBIT A and EXHIBIT B, and further referenced herein shall be in effect as of September 1, 2009.

SECTION 4: That this Board hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5: This Resolution shall take effect at the earliest period allowed by law.




