RESOLUTION 2017-01

RESOLUTION REQUESTING ADVANCE OF TAXES COLLECTED

The Board of Trustees of Union Township, Clermont County, Ohio met in special session at the Union Township Civic Center on January 3, 2017 with the following members present: Lloyd Acres, John McGraw, and Matthew Beamer.

Mr. Acres made a motion to adopt the following Resolution:

WHEREAS, Section 321.34 of the Ohio Revised Code authorizes townships to receive advances of taxes collected at the ensuing tax settlement; and

WHEREAS, the Union Township Board of Trustees request from the Clermont County Auditor advance payment of the current collection of taxes assessed and collected for Union Township at the 2016 tax settlement.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Union Township, Clermont County, Ohio by authority of Section 321.34 of the Ohio Revised Code, as follows:

SECTION 1: That the Fiscal Officer of Union Township formally submits a Request For Advance of Taxes Collected to the Clermont County Auditor for the first and second half tax settlement of 2016 collected in fiscal year 2017.

SECTION 2: That it is the Board's intent to use the money for the purposes of the fiscal year in which the request is made.

SECTION 3: That this Board hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4: This Resolution shall take effect at the earliest period allowed by law.

BE IT FURTHER RESOLVED that this Board, upon majority vote, does hereby dispense with the requirement that this Resolution be read on two separate days, and hereby authorizes the adoption of this Resolution upon its first reading.

BE IT FURTHER RESOLVED this resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

Mr. Beamer seconded the motion to adopt the Resolution. On the roll call being called the vote resulted as follows:


