## RESOLUTION 2017-14

### **RESOLUTION DECLARING CERTAIN PERSONAL PROPERTY OF UNION TOWNSHIP IS NOT NEEDED FOR PUBLIC PURPOSE, IS OBSOLETE, AND IS UNFIT FOR THE USE WHICH THE PROPERTY WAS ACQUIRED, AND APPROVING THE PRIVATE SALE OF THIS OUTDATED PROPERTY**

The Board of Trustees of Union Township, Clermont County, Ohio met in regular session at the Union Township Administration Building, 4350 Aicholtz Road, Cincinnati, OH 45245 on July 13<sup>th</sup>, 2017 with the following members present: Lloyd Acres, John McGraw, and Matthew Beamer.

Mr. Acres made a motion to adopt the following Resolution:

WHEREAS, Ohio Revised Code §505.10(A) provides that when a township has property, including motor vehicles, road machinery, equipment, and tools, and the Board, by resolution, finds is not needed for public use, is obsolete or is unfit for the use for which it was acquired, the Board may sell and convey that property or otherwise dispose of it as surplus in accordance with this Section of the Ohio Revised Code; and

WHEREAS, Ohio Revised Code §505.10(A)(2)(a) authorizes townships to sell property by way of private sale, without advertisement or public notification, in the event the Board of Township Trustees opine the fair market value of the property to be sold is two thousand five hundred dollars or less; and

WHEREAS, the Union Township Board of Trustees has determined that the township has certain obsolete and unfit personal property that is not needed for public use, which the Trustees believe have a fair market value of two thousand five hundred dollars or less;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Township Trustees of Union Township, Clermont County, Ohio:

1. In accordance with Ohio Revised Code §505.10(A)(2)(a), the Board of Trustees of Union Township does hereby find, in the opinion of the board, the following personal property is unfit for the use for which it was acquired, is obsolete, and is hereby authorized to be sold by private sale: fifteen (15) Remington 12-gauge guns, valued at a used fair market value of \$100.00 per gun; and five (5) semi-automatic shotguns, valued at a used fair market value of \$200.00 per gun.
2. Pursuant to Ohio Ethics Laws, no Union Township elected officials shall be able to purchase any of the private property as the sale will be private, and not by public auction or sealed bid.
3. That the Board by a majority vote hereby dispenses with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of the Resolution upon its first reading.
4. This Resolution is declared to be in full force and effect immediately upon its passage.
