RESOLUTION HONORING JOSHUA ANDREW BUNTON FOR ATTAINING THE RANK OF EAGLE SCOUT AND DECLARING JOSHUA ANDREW BUNTON DAY IN UNION TOWNSHIP

The Board of Trustees of Union Township, Clermont County, Ohio met in regular session at the Union Township Civic Center on August 10, 2017 with the following members present: John McGraw, Matthew Beamer & Lloyd Acres

Mr. McGraw _____ made a motion to adopt the following Resolution: 2017-15

WHEREAS, the Union Township Board of Trustees (BOARD) desires to acknowledge and recognize the positive efforts and outstanding achievements of Union Township Residents; and

WHEREAS, Joshua Andrew Bunton, a Union Township Resident and a member of the Mt. Moriah United Methodist Church Boy Scout Troop 671, Dan Beard Council in Cincinnati, Ohio, received his Eagle Scout Rank on June 6, 2017; and

WHEREAS, Mr. Bunton, successfully completed 39 merit badges and otherwise fulfilled the requirements necessary to attain the Rank of Eagle Scout, while serving in various leadership roles in Dan Beard Council Troop 671; and

WHEREAS, Mr. Bunton successfully completed a service project in order to attain the rank of Eagle Scout, more specifically, Mr. Bunton successfully constructed duck boxes at the Louis M. Groen Nature Preserve in Johannesburg, Michigan; and

WHEREAS, Mr. Bunton has demonstrated a life-long interest in environmental stewardship and conservation, involving himself in conservation and maintenance efforts at a very young age, and has expressed an interest to serve on the Louis M. Groen Nature Preserve Board in the future to ensure its status in perpetuity; and

WHEREAS, Mr. Bunton is also an active member in the West Clermont High School Marching Band, Concert Band, Jazz Band, OMEA District 14 Honor Band, Land of Grand Honor Band, Cincinnati Wind Youth Ensemble, Williamsburg Community Band, Student Council, West Clermont High School Leadership Program, and the Academic Team; and

WHEREAS, the Union Township Board of Trustees desires to honor and recognize Joshua Andrew Bunton for the accomplishments stated herein.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Union Township, Clermont County, Ohio, that August 10, 2017 be declared "Joshua Andrew Bunton Day" in Union Township.

BE IT FURTHER RESOLVED that this Board hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

BE IT FURTHER RESOLVED that this Board upon majority vote does hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorizes the adoption of this resolution upon its first reading

BE IT FURTHER RESOLVED that this resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.


