## RESOLUTION 2017-19

### RESOLUTION HONORING LINDSEY EIN FOR HER SERVICE AT INTERPARISH MINISTRIES AND FOR HER CONTRIBUTIONS TO UNION TOWNSHIP

The Board of Trustees of Union Township, Clermont County, Ohio met in regular session at the Union Township Civic Center on August 24, 2017 with the following members present: John McGraw, Matthew Beamer & Lloyd Acres

Mr. Acres made a motion to adopt the following Resolution: 2017-19

**WHEREAS**, the Union Township Board of Trustees (BOARD) desires to acknowledge and recognize the positive efforts and outstanding achievements of individuals living or working in Union Township; and

**WHEREAS**, Ms. Lindsey Ein served as the President and Chief Executive Officer of Inter Parish Ministries, a non-profit organization providing need-based assistance and food pantry service serving households in Clermont County, Eastern Hamilton County, and specifically in Union Township; and

**WHEREAS**, Ms. Ein served Inter Parish Ministries for nearly ten years with distinction in her role as the President and Chief Executive Officer of this charitable and philanthropic organization; and

**WHEREAS**, Ms. Ein was instrumental in the founding of the Clermont County Safety Net Alliance, thereby creating an organizational structure that allows social service non-profit organizations situated within the community to collaborate and share resources, thereby more effectively delivering needed services, clothing, and food to the most needy persons and families in Union Township and Clermont County, Ohio; and

**WHEREAS**, Ms. Ein most recently supervised the opening of the new Inter Parish Ministry office and food pantry location in Union Township; and

**WHEREAS**, this Board now desires to honor Ms. Lindsey Ein for her distinguished service and career with Inter Parish Ministries, and for her efforts to facilitate the provision of assistance to those most in need within Union Township and other surrounding communities.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of Union Township, Clermont County, Ohio, that August 24, 2017 be declared "Lindsey Ein Day" in Union Township.

**BE IT FURTHER RESOLVED** that this Board hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

**BE IT FURTHER RESOLVED** that this Board upon majority vote does hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorizes the adoption of this resolution upon its first reading

**BE IT FURTHER RESOLVED** that this resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
